FEDERAL DISASTER DECLARATION FACT SHEET

JUNE 16, 2015

Today, May 29, 2015, President Obama issued a major disaster declaration for the State of Texas triggering the release of Federal funds to help people and communities recover from the Severe Storms, Tornadoes, Straight-line Winds, and Flooding that occurred May 4, 2015, and continuing. **This disaster declaration has been amended as indicated below in bold.** Details of the disaster declaration and assistance programs are as follows:

Declaration Number: FEMA-4223-DR

Incident: Severe Storms, Tornadoes, Straight-line Winds, and Flooding

Incident Period: May 4, 2015, and continuing

Individual Assistance (IA): (Assistance for individuals and households):

IA-Designated Counties: Bastrop, Blanco, Caldwell, **Cooke, Dallas,** Denton, Eastland, **Fannin,** Fort Bend, Gaines, **Grayson,** Guadalupe, Harris, Hays, Henderson, Hidalgo, Johnson, **Liberty,** Milam, Montague, Navarro, **Nueces,** Rusk, Smith, Travis, Van Zandt, **Walker,** Wichita, Williamson, and Wise Counties.

Public Assistance (PA): (Assistance for emergency work and the repair or replacement of disaster-damaged facilities):

Hays, Henderson, Hood, Houston, Jasper, Johnson, Kaufman, Kendall, Lamar, Lee, Liberty, Lynn, Madison, Milam, Montague, Nacogdoches, Navarro, Newton, Polk, Refugio, Rusk, Sabine, San Jacinto, Travis, Tyler, Uvalde, Van Zandt, Walker, Williamson, Wharton, Wilson, Wise, and Zavala Counties.

Hazard Mitigation (HM): (Assistance for actions taken to prevent or reduce long term risk to life and property from natural hazards):

HM-Designated Areas: All areas in the State of Texas are eligible for assistance under the Hazard Mitigation Grant Program.

OTHER: Additional designations may be made at a later date if requested by the State and warranted by the results of further damage assessments.
