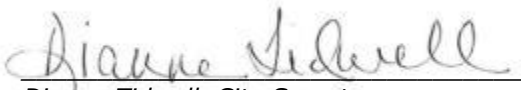

Ms. Herrington also stated that Sales Tax and Property Tax revenues were doing well and the General Fund balance is \$3.5 million.

Houston-Galveston Area Council - Councilperson Jordan

COMMENTS - Current Meeting:

Councilperson Jordan reported that he had recently attended the Houston-Galveston Area Council's (H-GAC) 2016 General Assembly. Councilperson Jordan also remarked that the City's new Fire Truck is a popular symbol of success for H-GAC as a major accomplishment in getting the rules of lending changed, and stated that the truck appears in numerous H-GAC literature.
